Commission Report on the Energy Community

- Adopted on 10th March 2011
- "Success story"
- Solid institutional framework for cooperation, mutual support and exchange of experience
- Model for regional cooperation on energy
- Main challenges
- Priorities



Main challenges

- (a) From theory to practice: Filling the gap between theory (political commitments) and practice (full implementation of the EnC acquis and enforcement of the adopted rules)
- (b) How to promote investments?: low level of private investments, due to lack of implementation of the rules + small scale of national markets + barriers to competition (regulated prices + subsidies + weak regulators)

First priority: focus on implementation and enforcement

- a) Impact of lack implementation on EU enlargement negotiations (e.g. reopening of energy chapter).
- b) Link between bilateral financial assistance and respect of commitments under EnC.
- c) Link to benefits under RES Directive.
- d) Preventive measures administrative cooperation and partnership
- e) Systematic recourse to the dispute settlement mechanism.
- f) Conditionality for new members / observers



Directorate-General

Second priority: Implementation of Third Package and Directives on RES & Energy Efficiency

- Essential for the integration of the Contracting Parties in the EU energy market
- Implementation of the rules as a key condition for the participation of the Contracting Parties in ACER or ENTSO



- Third priority: Coordinated investments strategy creating an attractive investment environment
 - Market reform required, covering:
 - » Price / subsidy reform
 - Social impact / vulnerable customers
 - Regional dimension
 - » Eligibility of infrastructure projects as "Projects of European Interest"
 - » Priority to regional projects: Gas Ring, e.g.
 - Strengthen respect of environmental criteria
