Ongoing projects Energy Efficiency in the Public Sector

- EE renovation and reconstruction of 25 state schools in Tbilisi
 - Council of Europe Development Bank loan & E5P grant
- Batumi Pre-Feasibility Study for introduction of an Energy Efficiency Framework and Short-Listing for Municipal Buildings
 - Being prepared with assistance from KfW



Future Steps Energy Efficiency in Public Sector

Support to Energy Efficiency and Sustainable Energy in Georgia

- Danish Government (DANIDA) & NEFCO program of technical assistance linked to financial support for energy-efficiency demonstration projects (public buildings) in Georgia
- Tbilisi Bus Project
 - Investments to purchase CNG buses for Tbilisi municipality EBRD & E5P
- Options for financing Energy Efficiency in public Buildings
 World Bank proposal for financial framework



Strategic Directions of Energy Policy Promotion of Energy Efficiency

Development of Georgia's first National Energy Efficiency Action Plan

- External background: signed EU Association Agreement (2014); Aspiring for full membership in the Energy Community
- Internal conditions: commitment to reduce dependence on energy imports and enhance energy security
- ➢ Georgia's first NEEAP launched in June 2015 → technical assistance received by EBRD and financial support by Swedish International Development Agency (SIDA)

Recommendations for Energy Efficiency in Public Sector according to draft NEEAP

The NEEAP will reflect the above projects and additional ambitions

Establish an Energy Efficiency Fund

which could focus on:

Project/investment identification, Donor coordination, Facilitation of grant-making, and Facilitation of technical assistance

Perhaps eventually lending-type investments (in conjunction with private capital) but not within the first few years

Develop a national energy efficiency information system for publicly owned buildings and street-lighting

Improvement of the data on the public building stock, lighting, and energy consumption

Pilot project for low energy public sector buildings

 Pilot project of renovation of administrative building to demonstrate the potential costs and benefits



Recommendations for Energy Efficiency in Public Sector according to draft NEEAP

- Efficient lighting systems in public buildings
- Improvement of the energy efficiency in central government-owned public buildings (schools, kindergartens, other type of buildings)

Green Procurement on Energy Efficiency

This measure involves adopting procurement regulations that would include operation and maintenance costs during the operational life-time of the energy consuming products, goods and services including buildings and transport means.

Improvement of efficiency in street-lighting/outdoor lighting
