Quotes are submitted at the risk of the bidders. All preparation and submission costs are at the bidder's expense.

1. INTRODUCTION

The purpose of this RFQ is to solicit quotations for **Fuel** as described in Attachment A.

Financing for the supply of the goods and/or services required under the present Request for Quotation comes from the Ukraine Energy Support Fund (the "Fund"). Therefore, involved in this project but not parties to the resulting contract are the following:

- (a) Tetra Tech Es, Inc., acting as procurement agent for the Ukraine Ministry of Energy and the Energy Community Secretariat (EnCS), is responsible to select the Supplier of the goods and/or services required and to negotiate the terms and conditions of the Supply Agreement that will result from this RFQ; and
- (b) The EnCS, acting as manager of the Fund, will be responsible to pay directly the Supplier of the said goods and/or services upon submission by the Client to the Fund of the Supplier's certified invoice confirming that the goods were delivered and/or the services provided in accordance with the terms of this Agreement.

2. BIDDER'S QUALIFICATIONS

Bidder must provide the following information and references in order to be qualified for the procurement process.

1. Company's information, including official registered name, place of registration, type of registration and number, company officers' names, business address, website, and physical address, telephone number, and email address of the firm's contact person;
2. Completely filled out Attachment A of this RFQ with prices and offered items
3. Bidders under sanction by the European Union or by virtue of a UN Security Council resolution will not be considered.
4. Source and Nationality: In addition to restrictions per Section (3) above, no firm whose beneficial owner is a national of and/or place of registration is in the Russian Federation or the Republic of Belarus is allowed to participate in the present tender. All bids must include proof of the country of origin and of the manufacturer in their proposal.

3. SUBMISSION OF QUOTATIONS

All quotations are due on **January 30, 2023**, by no later than **8:00 PM** local time in Kyiv, Ukraine. Quotations must be submitted via e-mail to the address **UES.Fundprocurement@tetrattech.com** in the following formats: Adobe Acrobat, Microsoft Word.

Quotations received after the above-stated due date and time will not be considered for this award.

4. QUESTIONS AND CLARIFICATIONS

All questions or clarifications regarding this RFQ must be submitted in writing in English and submitted to the email address **UES.Fundprocurement@tetrattech.com** by **January 26, 2023** no later than **8:00 PM** local time in Kyiv, Ukraine. Questions and requests for clarification, and the responses thereto, will be sent to all RFQ recipients.

Only written answers from Tetra Tech are official and carry weight in the RFQ process and subsequent evaluation. Any answers received outside the official channel, whether received verbally or in writing,

from employees or representatives of Tetra Tech, or any other party, will not be considered official responses regarding this RFQ.

5. EVALUATION CRITERIA

The award will be made to a responsible bidder whose quotation follows the RFQ instructions, meets the eligibility requirements, and meets or exceeds the minimum required technical specifications, and offered the lowest price technically acceptable (LPTA). Prices must be fair and reasonable. Bidders are encouraged to provide a discount to their standard commercial rates.

Tetra Tech reserves the right to conduct discussions with selected bidder(s) in order to identify the best value offer. Award of any resulting Purchase Order on a fixed-price basis shall be made by Tetra Tech on a best value basis. Tetra Tech reserves the right to request a test assessment from bidders to assess their qualifications.

6. DELIVERY TERMS

DDP Kharkiv, Ukraine (address to be determined in the Purchase Order) - 50,000 l

7. NEGOTIATIONS

Best offer quotations are requested. It is anticipated that a Purchase Order will be awarded solely based on the original offers received. However, Tetra Tech reserves the right to conduct discussions, negotiations and request clarifications prior to making an award. Furthermore, Tetra Tech reserves the right to conduct a competitive range and to limit the number of offerors in the competitive range to permit an efficient evaluation environment among the most highly-rated proposals. Highest-rated offerors, as determined by the evaluation committee, may be asked to submit their best prices during a competitive range.

8. MULTIPLE AWARD/NO AWARD

Tetra Tech ES, Inc. reserves the right to issue multiple awards. Tetra Tech ES, Inc. also reserves the right to issue no awards.

9. PAYMENT TERMS

Tetra Tech ES, Inc. acts as procurement agent on behalf of Energy Community Secretariat who is a fiduciary of the funds and a payer under this Purchase Order. Bidders should offer their payment terms and schedule in their bids which will be considered by Tetra Tech ES, Inc.

Payment shall be made by Energy Community Secretariat via bank wire transfer in **EUR** or **Ukrainian Hryvnias** per Raiffeisen Bank Aval interbank exchange rate.
