Find out about EU Member States' experience in reporting progress under Implementing Regulation (EU) 2022/2299

In 2025, Energy Community Contracting Parties started to report for the first time on the status of implementing their integrated National Energy and Climate Plans by means of integrated national energy and climate progress reports (IPR). The respective reporting obligation is detailed out under Article 17 of Regulation (EU) 2018/1999 and in the 23 Annexes of Implementing Regulation (EU) 2022/2299.

EU Member State practitioners already gained experience with reporting under this obligation during two reporting cycles. In this webinar series, they will share their insights - showcasing the institutional setup for reporting in their jurisdictions and discussing the various sources of data they activated to complete reporting under each of the 23 Annexes.
