- INITIATOR, COORDINATOR AND IMPLEMENTATION PARTNER OF VARIOUS ASSISTANCE PROJECTS
- ACTIVE SINCE 2013 (WPs 2013-2014/2015-2016/2017-2018/2019-2020)
