About the topic: In 2020 the climate transition required by the Paris Agreement collided with the COVID-19 pandemic. The impacts of this collision continue to unfold, with major consequences for the achievement of a just and clean energy transition. This presentation will examine developments in sustainable finance in the EU, other key jurisdictions and internationally in the period of pandemic 'stimulus' measures, from the perspective of implications for Energy Community Contracting Parties.

About the speaker: Dr Stephen Minas is associate professor at the School of Transnational Law, Peking University and senior research fellow at the Transnational Law Institute, King's College London, where Stephen completed a PhD in law. Stephen is vice-chair of the UNFCCC Technology Executive Committee and a member of the EU team in UN climate negotiations. Stephen has published and taught widely in the areas of international, EU, climate change and energy law, with a focus on technology and finance.
