




The new Labeling Regulations - in the EnC






- ♣ The adoption of Delegated Acts is in line with the Ministerial Council Decision 2010/02/MC-EnC
- Energy Efficiency Coordination Group discussed it and recommended the adoption of new EU Delegated Acts
- **♣** Energy Community Secretariat prepared the MC Decision adapting the new Delegated Regulations/EC comments
- The Ministerial Council decision will make them binding on the Contracting Parties
