Bosnia and Herzegovina

Status of transposition and implementation of requirements of EED and EPBD in Bosnia and Herzegovina

The primary legislation in the field of energy efficiency in Bosnia and Herzegovina:

- Law on Energy Efficiency of the Federation of Bosnia and Herzegovina
- Law on Energy Efficiency and the Law on Spatial Planning and Construction in Republika Srpska
- In Brčko district, the Law on Energy Efficiency is in the drafting procedure and there is no adopted secondary legislation
- Decision on the establishment of energy management system and information system of energy efficiency in institutions at the state level, Adopted, ([Official Gazette BiH, no. 48/19](#))
- Government of the Federation of BiH adopted the Energy Efficiency Action Plan of the Federation of Bosnia and Herzegovina for the period 2019-2021 ("Official Gazette of FBiH 11/21)
- Final drafts of the Energy Efficiency Action Plans of the Republika Srpska and Bosnia and Herzegovina for the period 2019-2021 are prepared, in proces of adoption
- NECP/ ECPs are in proces of development, final drafts expected by the begining of 2022

Status of implementation secondary legislation for EPBD in Bosnia and Herzegovina

According to the 2021 Federal Ministry of Physical Planning Work plan, in III quarter of 2021 following has been planned:

- Drafting amendments to the Law on Energy Efficiency in order to complete transposition of the EPBD Directive
- Making amendments to bylaws in the field of energy efficiency in order to fully transpose EPBD Directive

According to the 2021 Ministry of Construction, Civil Engineering and Ecology of RS Work Plan the following has been planned:

- Rulebook on regular inspections of technical systems for heating, ventilation and cooling of a buildings, II quarter
- Making amendments on Rulebook on performing energy audits of buildings and issuing energy certificates, III quarter
- Amendments to the rulebook on the methodology for calculation of the energy performance of buildings
- Amendments to the Rulebook on minimum requirements for energy performance of buildings
