Levels of implementation


- Roles of ENTSO-E and the EU TSOs with regard to the implementation of the EnC acquis are defined under EU law. Further, in the case of the EU TSO's neighbouring their EnC counterparts in the EnC legislation based on EnC Title III ensuring reciprocity.
- Roles of EnC Secretariat and EnC TSOs are defined in the adapted legislation, in accordance with EnC Treaty

Several levels of implementation obligations ('legal mandates') should be distinguished:



In a sense, the duties of the TSOs kick in as soon as the transpositions in the Contracting Parties have entered into force

Transposing the EnC Legal Acts into the national frameworks of the Contracting Parties



What? Inclusion of all adapted legislation in the legal frameworks of the contracting Parties (laws, rulings, grid codes)

Who? EnC Contracting Parties (governments accountable)


EnC Secretariat: EnC implementation monitoring and reporting; alignment European Commission

European Union interest: Infringements to be brought to European Court of Justice

ENTSO-E involvement: EnC Taskforce (legal and technical) support and internal ENTSO-E alignment



Activate the EnC System Operation Regions (SORs) and Capacity Calculation Regions (CCRs)



What? Conclude agreements on, and activate Shadow SEE and EE CCRs and SORs


Who? EnC TSOs, subsets: Western Balkan 6 (Shadow SEE) and UA/MD (EE) and their EU neighbours

EnC Secretariat: EnC implementation monitoring and reporting: EnC TSOs support

European Union interest: ACER for approvals; European Commission on progress

ENTSO-E involvement: EnC Taskforce alignment platform; gearing up ENTSO-E coordination bodies

What? Roll-out of Market coupling and Balancing Platform IFs

Who? EnC TSOs and NEMOs, subsets: Western-Balkan 6 and UA/MD


EnC Secretariat: EnC implementation monitoring and reporting; EnC TSOs and NRAs' support

European Union interest: ACER for approvals; progress monitoring through CACM Pentalateral Coordination Group

ENTSO-E involvement: Coordination through Market Committee (MIWG and WG AS) and System Operations Committee (StG. Strategy) – connection with implementation projects MRC, XBID and Balancing Platforms (TERRE, MARI, PICASSO and IGCC)



Regional Coordination Centres (RCCs) operationalisation



What? Conclude Service-Level Agreements (SLAs); cooperation agreements between RCCs operating in one region

Wha? EnC TSOs and RCCs (SCC and SEIoNo)

Who? EnC TSOs and RCCs (SCC and SEleNe)
