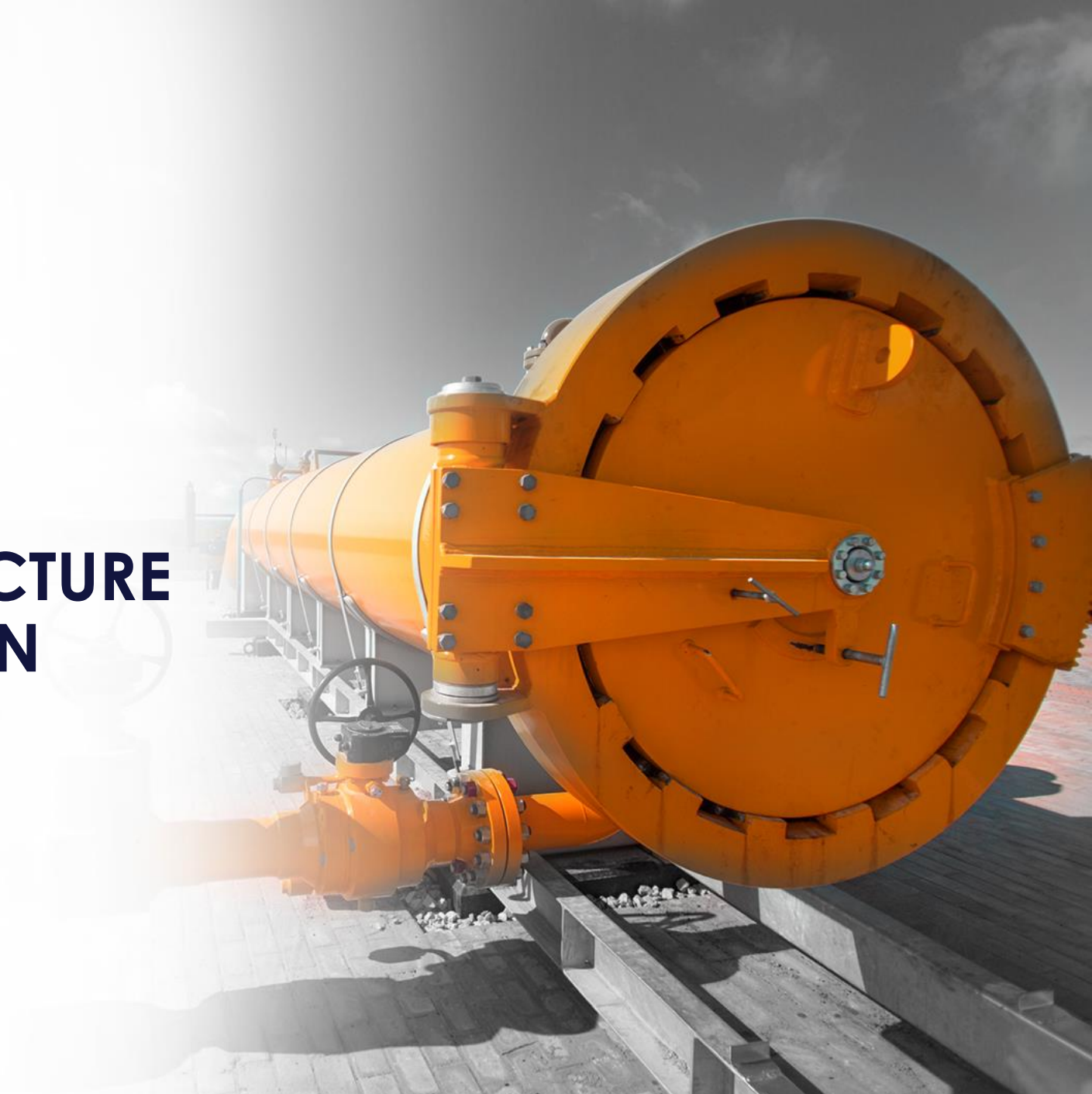

GAZ-SYSTEM'S STRATEGIC PROJECTS

10 bcm/year (to PL)
3 bcm/year (to DK)

Commissioning: October 2022

**EXTENSION OF LNG TERMINAL
IN ŚWINOUJŚCIE**

Current capacity: 6,2 bcm/year

After full expansion: 8,3 bcm/year.

Commissioning: December 2023

NORTH-SOUTH CORRIDOR

Operational in 2022

FSRU GDAŃSK

At least 6,1 bcm/year. Commissioning: 2027

Possible expansion of the capacity up to 12 bcm/ year

EXPANSION OF LNG TERMINAL IN ŚWINOUJŚCIE

LNG Terminal in Swinoujscie operates since 2015.

Original LNG Terminal capacity: 5 bcm/y
Capacity in January 2022: 6,2 bcm/y
Capacity after expansion in 2023: 8,3 bcm/y

- SCV project
- Third LNG tank project
- Second jetty project

Ongoing construction works on jetty and 3rd LNG tank.
Additional SCVs completed

Expected commissioning date:

- 12.2023

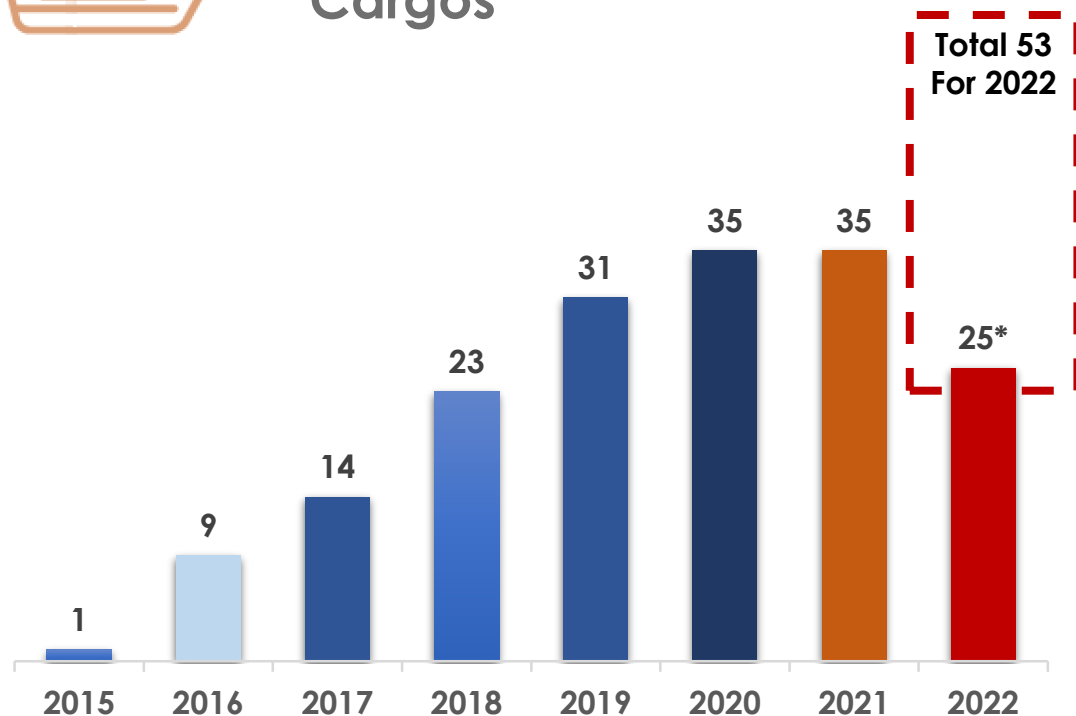

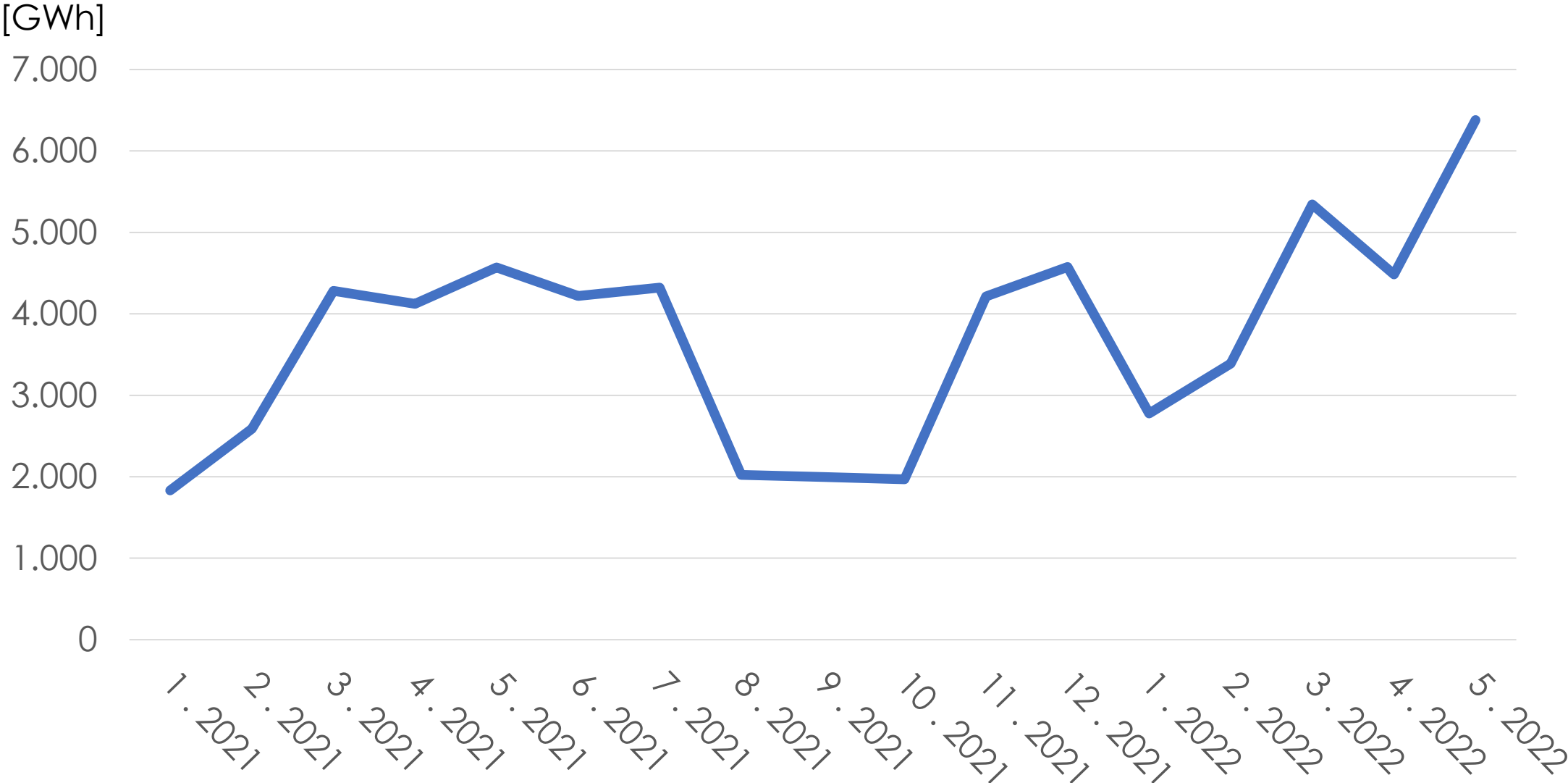


LNG Trucks

FSRU GDAŃSK

Description of the investment:

The investment involves the location of a floating FSRU (Floating Storage Regasification Unit) in the Gdańsk region, capable of unloading LNG, process storage and regasification of LNG, as well as providing additional services.

The European Commission has awarded the project the status of "Project of Common Interest".

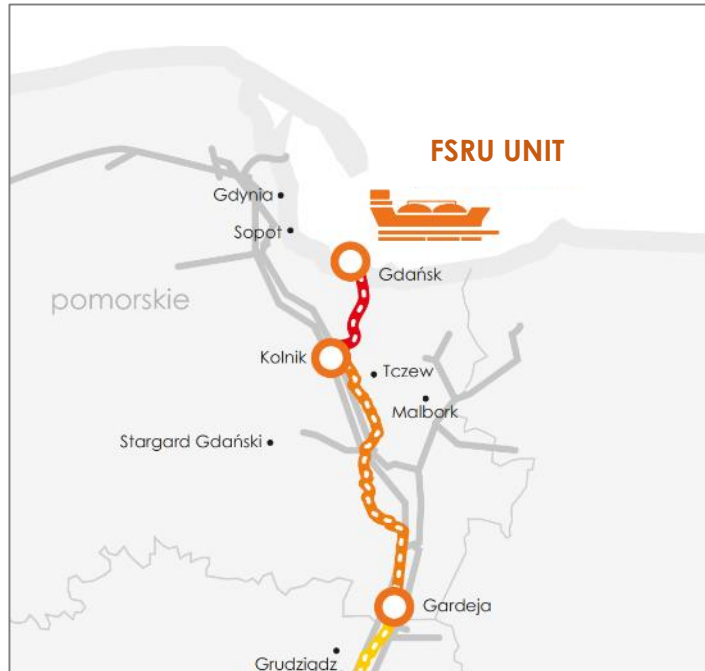
The program has been included in the fourth and fifth lists of projects of common interest for the European Union (PCI list), as part of the priority corridor: 6. North-South gas interconnections in Central-Eastern and South-Eastern Europe ('NSI East Gas') 6.27 LNG Gdańsk (PL)]

Current status:

- ❑ **1st Open Season Phase completed, proving the economic viability of the project.**



FSRU PROGRAM - system of offshore and onshore pipelines, a jetty and regasification unit

Main scope of the project:

- FSRU vessel
- Construction of a jetty
- Connection of a FSRU with the Polish Transmission System
- Development of the Polish Transmission System

The current regasification capacity – which GAZ-SYSTEM has committed to in the Open Season procedure until 2027 – is 6.1 bcm.

Constructed jetty adapted to the delivery of the second unit – increasing the capacity to 10-12 bcm per year.
