

DECISION No. 2007/06/MC-EnC

of 18 December 2007 on the implementation of Directive 2005/89/EC, Directive 2004/67/EC and Regulation (EC) N° 1775/2005

The Ministerial Council of the Energy Community,

Having regard to the Treaty Establishing the Energy Community, and in particular Articles 2, 100 (ii) and 103 thereof,

Whereas the Ministerial Council decided on 29 June 2007 to implement Directive 2005/89/EC, Directive 2004/67/EC and Regulation (EC) N° 1775/2005 and requested the Permanent High Level Group to propose the requisite legal acts, including timetables for implementation,

Whereas the Permanent High Level Group, at its meeting on 17 October 2007, elaborated and proposed to adopt the present Decision,

HAS ADOPTED THIS DECISION:

Article 1

- 1. Each Contracting Party shall implement Directive 2005/89/EC concerning measures to safeguard security of electricity supply and infrastructure investment before 31 December 2009.
- 2. For the implementation of Directive 2005/89/EC in the Contracting parties, at the exception of its Articles 8 and 9, the term "Member States" shall apply by analogy to "Contracting Parties".
- 3. The Secretariat shall monitor and review the implementation of Directive 2005/89/EC in the Contracting Parties and shall submit a progress report to the Permanent High Level Group by 30 June 2010.

Article 2

- 1. Each Contracting Party shall implement Directive 2004/67/EC concerning measures to safeguard security of natural gas supply before 31 December 2009.
- 2. For the implementation of Directive 2004/67/EC in the Contracting Parties at the exception of its Articles 10 and 11, the term "Member States" shall apply by analogy to "Contracting Parties".
- 3. For the implementation of Directive 2004/67/EC in the Contracting Parties, the Coordination Group referred to at its Article 7 will be set up by a Procedural Act to be adopted by the Permanent High Level Group.



4. The Secretariat shall monitor and review the implementation of Directive 2004/67/EC in the Contracting Parties and shall submit a progress report to the Permanent High Level Group by 30 June 2010.

Article 3

- 1. Each Contracting Party shall implement Regulation (EC) N° 1775/2005 on conditions of access to the natural gas network before 31 December 2008.
- 2. For the implementation of Regulation (EC) N° 1775/2005 in the Contracting Parties, the term "Member States" shall apply by analogy to "Contracting Parties".
- 3. The Secretariat shall monitor and review the implementation of Regulation (EC) N° 1775/2005 in the Contracting Parties and shall submit a progress report to the Permanent High Level Group by 30 June 2009.

Article 4

This Decision enters into force on the day of its adoption and is addressed to the Contracting Parties.
