I. Energy Support Package (1)

3 November 2022: WB Berlin Process Summit

Two main components:

- ➤ Immediate term measures: EUR 500 million budget support to:
 - Balance the increase of energy prices for businesses and energy sector.
 - Keep energy prices affordable for vulnerable households.
- ➤ Short to medium term measures: EUR 500 million through WBIF to:
 - Advance on energy diversification, renewable energy generation and gas and electricity interconnections.
 - Support the energy transition of the business sector and energy efficiency installations.

I. Energy Support Package (3)

EUR 500 million through **WBIF** to support the region with **short to medium term measures** to advance the energy transition and energy security:


- Replenishment of the energy efficiency support scheme REEP for the WB: additional EUR 100 million to finance energy efficiency measures in the public and private sectors.
- EUR 170 million public and private sector blending investments in the energy sector (e.g. electricity and gas interconnectors; renewable energy generation; electricity transmission systems)
- **EUR 230 million in guarantees** to support investments in energy transition and security

Since its inception in 2009, the WBIF supported **project preparation / implementation with TA** for public sector blending with EUR 61 million of grant support

Total investment grant support provided for energy sector reached EUR 256 million

Total EU support provided to the REEP amounts to EUR 182 million

Six renewable energy investments

- > Two solar **photovoltaic plants** in Kosovo.
- > Two wind parks farms in North Macedonia and Serbia.
- Rehabilitation of two hydropower plants in North Macedonia and Serbia.

This comes on top of six energy projects approved by the WBIF board in 2021 and 2020 in Serbia, Albania and North Macedonia.



- Support to development and implementation of Sustainable Energy and Climate Action Plans
- Small-scale energy efficiency and renewable energy projects
- Examples:
- (1) Roof insulation on a cultural centre in Berane, MNE
- (2) PV to supply water pumps for agriculture in Roskovec, ALB
- (3) PV for a wastewater treatment plant in Vevcani, NME
